AN ORDINANCE AMENDING ORDINANCE NO. 7192, OTHERWISE KNOWN AS §37.006 OF THE HAMMOND MUNICIPAL CODE, PERTAINING TO COMMUNITY AND PROFESSIONAL DEVELOPMENT ACCOUNTS

WHEREAS, the Common Council of the City of Hammond passed Ordinance No. 7192 authorizing the Common Council, through a municipal promotions account, to pay the expenses of or to reimburse city officials for expenses incurred in promoting the best interest of the city; and

WHEREAS, Ordinance No. 7192 was passed thirty-three years ago and must therefore be updated to continue promoting the best interest of the city; and

WHEREAS, the Common Council of the City of Hammond now wishes to amend
Ordinance No. 7192 to rename any "Municipal Promotions" accounts to that of "Community and
Professional Development" accounts and to authorize additional authorities to pay the expenses
of or to reimburse city officials for expenses incurred; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond, Indiana that Ordinance No. 7192, otherwise known as §37.006 of the HMC, be amended to read as follows:

§37.006 COMMUNITY AND PROFESSIONAL DEVELOPMENT; APPROPRIATION OF FUNDS.

(A). The Common Council, Mayor, Fire Department, and Police Department are authorized to establish a line item in the budget and may appropriate funds from the general fund

of the city to pay the expenses of or to reimburse city officials for expenses incurred in

promoting the best interest of the city.

(B) The expenses may include, but are not necessarily limited to, rental or meeting

places, meals, decorations, memorabilia, awards, expenses incurred in promoting industrial,

commercial and residential development, expenses incurred in interviewing job applicants,

expenses incurred in development relations of other units of government and any other expenses

of a civic or governmental nature deemed by the Common Council, Mayor, Police Department,

or Fire Department to be in the interest of the city.

(C) The expenses shall not include the purchase of raffle or lottery tickets in the name of

any public official nor shall they include the purchase of tobacco or alcoholic beverages.
