ORDINANCE NO. 9593

AN ORDINANCE CREATING A NEW FUND (FUND #2474) AND TO APPROPRIATE FUNDS WITHIN THE PARKS DEPARTMENT FOR THE HARRISON PARK RESTORATION PROJECT GRANT

WHEREAS, the Lake Michigan Coastal Program (LMCP) supports coordination and partnership amount local, state, and federal agencies for the protection and sustainable use of natural and cultural resources in the Lake Michigan region; and

WHEREAS, through the LMCP the City of Hammond Parks Department is the recipient of a matching grant in the amount of \$100,000 for the purpose of restoring Harrison Park; and

WHEREAS, the City of Hammond requires the use of monies received from the LMCP which requires creation of a Fund (#2474) and an appropriation; and

WHEREAS, these funds are available to meet match requirements and will be used for and appropriated to newly created fund #2474; and

WHEREAS, this transaction, being an appropriation must have a public hearing for which the Clerk of the Common Council is hereby directed to make arrangement, and being subject to approval by the Department of Local Government Finance; and






