WHEREAS, the Rural and Small Department Violent Crime Reduction Program, administered by the Bureau of Justice Assistance (BJA) provides funding to small and/or rural agencies who are interested in implementing or improving the capacity of their organization around BJA critical elements such as, community engagement, technology, training, tactics, and intelligence; and

WHEREAS, after successful application to the program, the BJA has awarded the City of Hammond Police Department \$300,000.00 for FY2023 for the purpose of implementing gunshot technology to improve public safety, decrease gun violence, and increase timely medical assistance; and

WHEREAS, the City of Hammond Police Department requires the use of these monies received from the Rural and Small Department Violent Crime Reduction Program which requires a dedicated fund to receipt and disburse this allocation of grant money; and
