AN ORDINANCE CREATING A NEW FUND (FUND #2502) FOR THE DIESEL EMISSION REDUCTION SUPPLEMENTAL ENVIRONMENTAL PROJECT FUNDS ALLOCATED TO CITY OF HAMMOND

WHEREAS, on May 17, 2023, the U.S. Environmental Protection Agency and the Department of Justice announced a Clean Air Act Settlement with BP Products North America Inc. (BPP), which BPP, in part, agreed to undertake a supplemental environmental project to reduce diesel emissions in the communities surrounding the Whiting Refinery; and

WHEREAS, a Consent Decree filed with the U.S. District Court for the Northern District of Indiana indicated BPP will spend \$1.25 million dollars to replace existing diesel vehicles owned and used by local governments and non-profit organizations within the communities closest to the Whiting Refinery, including the City of Hammond; and

WHEREAS, the City of Hammond requires the use of these monies received from BPP which requires a dedicated fund to receipt and disburse this allocation; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account be dedicated and created for the City of Hammond for purposes of accessing these funds; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:
