## AN ORDINANCE CREATING A NEW FUND (FUND #4655) FOR THE FUNDS ALLOCATED TO CITY OF HAMMOND BY LAKE COUNTY, INDIANA FOR THE CONSTRUCTION OF FIRE STATION NO. 2

WHEREAS, on September 25, 2023, the Hammond Common Counsel passed
Resolution 2023-07 May 17, 2023, approving and entering into a joint interlocal governmental
