Garage Sale Liability Waiver and
COVID-19 Pandemic Precautions**

Additional Rules and Preconditions to Issuing of Garage Sale Permit:

In an effort to prevent the further spread of COVID-19 and in accordance with all local, state, and federal guidance, the following rules are being implemented for any City of Hammond resident requesting a garage sale permit and I agree to follow them:

1. The garage sale permit holder shall practice social distancing by doing the following:
 - a. Place posters or signs encouraging social distancing (6 feet of separation) for customers to see upon arrival and while shopping.
 - b. Set up all tables with merchandise and chairs at least 6 feet apart from one another.
 - c. During high traffic times, instruct customers to stand 6 feet apart while checking out.
2. The garage sale permit holder and those working or volunteering at the garage sale are highly recommended to wear masks and disposable gloves at all times during the sale.
3. The garage sale permit holder shall clean all tables and chairs and any other “high touch” surface areas several times throughout the day.
4. The garage sale permit holder shall have hand sanitizer with at least 60% alcohol easily assessable for all customers during the sale.

Waiver

I release and will not hold the City of Hammond or any of its employees or agents liable or responsible in any way for any liability arising out of me receiving a garage sale permit including but not limited to any liability as a result of anyone contracting COVID-19 at my sale. I also understand the above stated rules and preconditions regarding COVID-19 precautions and agree to comply with them. I understand that as a condition of obtaining a garage sale permit under Section 113.41 of the City of Hammond Code of Ordinances that I am agreeing to abide by the above COVID-19 Rules and that failure to do so will allow the City of Hammond the right to revoke the garage sale permit for any violation of the above stated rules and regulations.
