**ORDINANCE NO. 9241**

**AN ORDINANCE REPEALING ORDINANCE 7983 AND ORDINANCE 8022 ALSO  
KNOWN AS SECTION 33.02 OF THE HAMMOND MUNICIPAL CODE**

WHEREAS, Ordinance 7983 and 8022 also known as Section 33.02 of the Hammond Municipal Code establishes separate and distinct vacation benefits for Hammond firefighters; and

WHEREAS, for all other departments, where a collective bargaining agreement is not being utilized, vacation benefits are found in Chapter 37 of the Hammond Municipal Code, and Section 37.020 of that Chapter, incorporates the Hammond Personnel Policy Manual by reference; and

WHEREAS, The Hammond Common Council now wishes to repeal Section 33.02 and address the issue of firefighter vacation and other benefits in Chapter 37 of the Hammond Municipal Code by way of separate Ordinance; and

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Common Council of the City of Hammond that Ordinance 7983 and 8022, also known as Section 33.02 of the Hammond Municipal Code is now repealed and will be replaced by a new Section of Chapter 37 of the Hammond Municipal Code; and

BE IT FURTHER ORDAINED by the Hammond Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
