ORDINANCE NO. 9320

**AN ORDINANCE TO APPROPRIATE FUNDS WITHIN THE HAMMOND POLICE
DEPARTMENT GRANT FUND**

WHEREAS, The Indiana Criminal Justice Institute (ICJI) annually offers traffic safety grant money to local law enforcement agencies and Hammond received an award of these funds; and

WHEREAS, the City of Hammond Police Department requires the use of monies received from the Indiana Criminal Justice Institute (ICJI) which requires an appropriation; and

WHEREAS, ICJI has awarded the City of Hammond Police Department \$75,000 from, the Operation Pull Over Grant and \$8,000 for the Pedestrian and Bicycle Safety Grant; and

WHEREAS, these funds are currently available and will be used for and appropriated to funds #227 and #226 respectively; and

WHEREAS, this transaction, being an appropriation must have a public hearing for which the Clerk of the Common Council is hereby directed to make arrangements, and being subject to approval by the Department of Local Government Finance.
