**A RESOLUTION AUTHORIZING THE HAMMOND POLICE DEPARTMENT TO
APPLY FOR A 2020 LAKE COUNTY DRUNK DRIVING TASK FORCE GRANT**

WHEREAS, The Indiana Criminal Justice Institute (ICJI) annually offers Drunk Driving prevention grant money to local law enforcement agencies; and

WHEREAS; currently a grant is available for the Hammond Police Department, through Lake County, which funds are allocated for the purpose of preventing Drunk Driving injuries and fatalities; and

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant which is being requested in the amount of \$80,000.00; and

WHEREAS, the City of Hammond must apply for to be awarded these grant funds and the Hammond Police Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and


