

BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF AUGUST 30, 2018

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:00 a.m. on Thursday, August 16, 2018, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Garay - absent; Mr. Margraf – present; Mr. Long – present.

Due to the absence of Ms. Garay, normal rules of procedure are suspended.

Recommendation by Mr. Margraf to defer approval of the minutes of the meeting of July 19, 2018 and July 26, 2018; Mr. Long concurred.

Request for bid dates of September 6, 2018 and September 13, 2018 with a bid opening date of September 27, 2018 for the 4th District Lighting 2018 Project – Van Buren Avenue – Locust Street to Vine Street, Madison Avenue – 169th Street to 165th Street, Woodland Avenue - 176th Street to 174th Place, Maplewood Avenue – 175th Place to 174th Place, 175th Place – Woodland Avenue to Tapper Avenue, 175th Street – Calumet Avenue to Tapper Avenue, 174th Place – Calumet Avenue to Tapper Avenue. Recommendation by Mr. Long; Mr. Margraf concurred. (Res. No. 2838)

Status hearing on property located at 227 Chicago Street. Mr. Kelly Kearney, Chief of Inspections, said the service line has been cut at the main and needs to be back filled. Mr. Kearney

then requested this matter be continued. Recommendation by Mr. Long to continue this matter to September 13, 2018; Mr. Margraf concurred. (Ins. No. 18-729)

Under Old Business, a request to hold a Stop and Prayer at the corner of Lyman Avenue and 173rd Street. Representative of Fellowship of Love Christian Center fails to appear. Recommendation by Mr. Long to continue this matter to September 6, 2018; Mr. Margraf concurred. (Ins. No. 18-743)

Under Meeting Opened to the Public, Mr. Peter Stofjik addressed the Board. Mr. Stofjik said a truck hit the guard rail in back of his house and the trucking company at fault said they would pay for repair but they need an estimate of cost. Mr. Stofjik said he has been unable to find a company willing to give an estimate. Mr. Kearney gave Mr. Stofjik his card and said that he will confirm the guard rail is City owner, and if so, help obtain an estimate.

Pastor Derek White, Fellowship of Love Christian Center, appears and said the Stop and Prayer request will not have any impact on traffic, there will only be two (2) people at a time at the corner, and will not coerce people in any way. Pastor White then requested this be allowed from 11:00 a.m. to 3:00 p.m. Recommendation by Mr. Long to cancel the request for the Church to appear before the Board on September 6, 2018 and to approve the request; Mr. Margraf concurred.

Mr. Gary Dreischerf, a resident of the 6700 block of Alexander Avenue, addressed the Board and said the condition of his street is terrible, that he has called Councilman Woerpel about it but has never received a return call and he would like to know when the block will be reconstructed. Mr. Long said he will speak with him after the meeting.

There being no further business to come before the Board, recommendation by Mr. Margraf to adjourn; Mr. Long concurred. The regularly scheduled meeting adjourned at 9:29 a.m.
