**AMENDED ORDINANCE NO. 9271**

**ORDINANCE TO APPROVE TRANSFER OF FUNDS TO THE GENERAL FUND**

WHEREAS, the Hammond Common Council may by ordinance approve the transfer of money from one fund to another in need of money for cash flow purposes;

WHEREAS, Heather Garay, the City Controller, has advised, and the Hammond Common Council does find, that funds are available, the transfer is necessary to cover expenses, and that the transfers be made by proper ordinance at a regular public meeting of the Hammond Common Council; and

WHEREAS, this transaction is not an additional appropriation and a public hearing is not required; and

WHEREAS, the Hammond General Fund, Fund No. 101, is in need of money to pay expenses of the City of Hammond; and

WHEREAS, the Hammond Riverboat Fund, Fund No. 240, has in excess of Two Million Two Hundred Twenty Two Thousand, Eight Hundred Dollars and No/100 (\$2,222,800.00) which can be used by the Hammond General Fund to pay City expenses.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be authorized to provide the following transfer:
