

**BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF FEBRUARY 17, 2022**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:04 a.m. on Thursday, February 17, 2022, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Margraf – present; Mr. Long – present; Mr. Perez – present.

Under Matters from Other Department Heads, Mr. Button advises that NIPSCO will be using Clark athletic property as a staging area for their continued infrastructure within the city.

Under Correspondence, correspondence received from HC3 Vice President, Geoffrey Cardwell, requesting approval of road closures on Kennedy Avenue from 173rd Street to 172nd Street for the 6th Annual Live in the Ville from Friday June 3, 2022 at 12:00 p.m. to Sunday, June 5, 2022 at 1:00 a.m. Motion by Mr. Long to approve; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-071)

Notification from NIPSCO advising of rolling slowdowns on 80/94 for Conflict 190 for the Westlake Project on February 19, 2022 and February 20, 2022. No action taken. (Ins. No. 22-072)

Correspondence received from Ron Novak requesting the approval of the Proposed License Agreement for the property located at Roosevelt Street and White Oak Avenue. Motion by Mr. Long to approve; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-073)

Correspondence received from Councilman Mark Kalwinski requesting a “CROSS TRAFFIC DOES NOT STOP” sign at the intersection of Cameron and 143rd Street and a traffic/safety study to ascertain whether stop signs should be installed, or whether other alternatives may be suitable to promote a safer environment. Motion by Mr. Long to forward to Engineering; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-074)

Correspondence received from Dean Button requesting permission to hold the 2022 Riot Criterium on Saturday May 7, 2022 from 8:00 a.m. to 4:00 p.m. and requests certain lane restrictions from 6:00 a.m. to 6:00 p.m. Motion by Mr. Long to approve; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-075)

Right of Way Permit submitted for approval from Engineering Department. Motion by Mr. Long to approve; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-076)

Under New Business, Agreement to Rehabilitate Property Located at 4240 Wabash submitted for approval. Motion by Mr. Long to approve and set for status on June 2, 2022; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-077)

Under Old Business, Status – 1152 Roosevelt St. (Front and Garage). Motion by Mr. Long to set for status on April 21, 2022; seconded by Mr. Perez. AYES ALL. Motion carried.

Status – 90-day trial period for temporary residential signs on Hyslop and Park Place from Highland Street to Waltham Street. Motion by Mr. Long to approve additional 90-days and set for stats on May 26, 2022; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-078)
