

BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF JUNE 9, 2022

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:08 a.m. on Thursday, June 9, 2022, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Margraf – present; Mr. Long – present; Mr. Perez – present.

Motion by Mr. Long to approve the Minutes of the meeting of June 2, 2022; seconded by Mr. Perez. AYES ALL. Motion carried.

Under Correspondence, correspondence received from City Engineer, Dean Button requesting \$80,065.00 of CIB Funding to be allocated for additional environmental services with American Structurepoint, Inc. for the Hohman Avenue Phase 2 – Russell Street to Douglas St. (Des. No. 2002586) and corresponding Amendment No. 1. Motion by Mr. Long to approve; seconded by Mr. Perez. AYES ALL. Motion carried. (Ins. No. 22-338)

received one quote at this time. Mr. Smith would like to present the Findings & Order on property and indicate the Board request this an emergency so Mr. Kearney can operate under the Unsafe Building Act and won't have to go through the regular bid process. Owner is deceased, granddaughter staying there, no insurance. 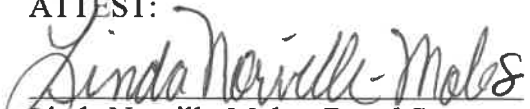
