

**BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF AUGUST 15, 2024**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:03 a.m. on Thursday, August 15, 2024, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Long – present; Ms. Greenwell – present; Mr. Kalina – present.

Motion by Ms. Greenwell to approve the Minutes of the meeting of August 8, 2024; seconded by Mr. Kalina. AYES ALL. Motion carried.

Under Matters from Other Department Heads/Their Representatives, Mr. Gordish advises that Milestone will reduce northbound and southbound traffic on Indianapolis Blvd. from 167th St. to 165th St. to one lane in each direction as part of Phase 1 and will begin on/after August 21, 2024 until late October. (Ins. No. 24-453)

Mr. Gordish requests approval for ICC Group to keep Ash Avenue open to the parking lots of both businesses and no parking signs on the east side of Ash Avenue between the bridge and Chicago Ave to the closure to accommodate wide loads to/from the businesses. 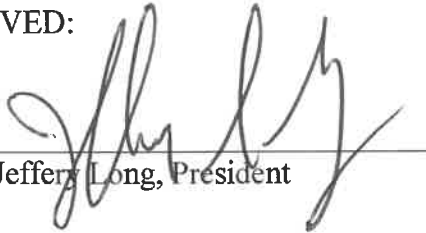
