ORDINANCE 9322

**AN ORDINANCE TO APPROPRIATE NEW FUNDS TO THE OPERATING BALANCE FOR THE HAMMOND SANITARY DISTRICT'S SEWER MAINTENANCE FUND (608)**

WHEREAS, the Hammond Sanitary District, by its Board of Commissioners, requires the use of monies in the operating balance for personal services and other services & charges; and

WHEREAS, these funds are currently available in the operating balance of the Sewer Maintenance Fund (608) and need to be appropriated; and

WHEREAS, it has been determined that it is now necessary to appropriate more money than was originally appropriated in the annual budget; and

WHEREAS, this transaction, being an appropriation must have a public hearing for which the Clerk of the Common Council is hereby directed to make arrangements, and being subject to approval of the Department of Local Government Finance; now

**THEREFORE BE IT ORDAINED** by the Hammond City Council, Lake County, of the Sanitary District of Hammond, Lake County, that for the expenses of the Sewer Maintenance Fund (608) the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to laws governing the same:
