AN ORDINANCE FIXING THE SALARIES FOR ELECTED CITY OFFICIALS  
FOR THE CITY OF HAMMOND, INDIANA COMMENCING JANUARY 1, 2016  
BE IT ORDAINED BY THE COMMON COUNCIL of the City of Hammond, Indiana

**SECTION ONE:** For the calendar year 2016 the salary schedule for elected officials of the City of Hammond, Indiana shall be fixed as follows:

**SECTION TWO:** For 2016, the paydays shall be every other Friday commencing on January 1<sup>st</sup>, 2016 for a total of 27 pays.

**SECTION THREE:** The City shall pay the 3% contribution in PERF for those officials who do not already participate in another retirement or pension plan supported in whole or in part by the state or political subdivision of the State, as of January 1, 1992.

**SECTION FOUR:** This ordinance shall be in full force and effect from and after January 1, 2016 upon signing by the President of the Common Council, approval by the Mayor, and Publication as provided by law.
