**AN ORDINANCE APPROPRIATING FUNDS FROM LOCAL PRETRIAL DIVERSION AND DEFERRAL FUND WITHIN THE HAMMOND CITY COURT 2016 BUDGET TO FUND PART TIME SALARIES**

WHEREAS, The Hammond City Court, requests that certain City Court account funds be appropriated within the Local Pretrial Diversion and Deferral Fund for part time salaries to cover personnel expenses related to the operation of the Court; and

WHEREAS, Heather Garay, the City Controller, has advised, and the Hammond Common Council does find, that funds are available, the appropriation is necessary to fund the City Court Part Time Salary account for the balance of 2016, that the appropriation does not require the expenditure of more money than the amount set out in the 2016 Court budget, and that the appropriations be made by proper ordinance at a regular public meeting of the Hammond Common Council; and

WHEREAS, this transaction is in compliance with I.C. 33-37-8-4 as the funds will be used for personnel expenses related to the operation of the program; and

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be authorized to appropriate following fund balances:
