AN ORDINANCE TO APPROPRIATE FUNDS WITHIN THE HAMMOND POLICE DEPARTMENT GRANT FUND FOR 2018

WHEREAS, The Indiana Criminal Justice Institute (ICJI) annually offers traffic safety grant money to local law enforcement agencies and Hammond received an award of these funds; and

WHEREAS, the City of Hammond Police Department requires the use of monies received from the Indiana Criminal Justice Institute (ICJI) which requires an appropriation; and

WHEREAS, ICJI has awarded the City of Hammond Police Department \$93,500 from, the Operation Pull Over Grant and \$12,500 for the Pedestrian and Bicycle Safety Grant; and
