**ORDINANCE NO. 9395**

**AN ORDINANCE CREATING A NEW NON REVERTING FUND (FUND #205) FOR  
PARK DEPARTMENT DONATIONS**

WHEREAS, The City of Hammond Department of Parks and Recreation from time to time is approached with donated funds; and

WHEREAS, The City of Hammond Department of Parks and Recreation wishes to create an account for the receipt and expenditure of such funds; and

WHEREAS, The City of Hammond Board of Park Commissioners has passed Resolution Number 17-04 seeking to have the Hammond City Controller create a new fund for the receipt and expenditure of donated funds to be overseen by the Board of Park Commissioners ; and

WHEREAS, The City of Hammond, Indiana, Department of Parks and Recreation, Board of Park Commissioners, now requests that a new non reverting account, number 205-367.00 and 205-439.00-550, be dedicated and created for the receipt and distribution of donated funds.

WHEREAS, the creation of this fund is not an additional appropriation, and a public hearing is not required.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate and create a new non reverting account for the City of Hammond Department of Parks and Recreation, Board of Park Commissioners.

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor and approval of the DLGF.
