AN ORDINANCE CREATING A NEW FUND (FUND #278) FOR THE CITY HAMMOND POLICE DEPARTMENT FOR FY2020 STOP ARM VIOLATION ENFORCEMENT (SAVE) GRANT FUNDS

WHEREAS, Resolution No. 20R-07 adopted and approved on the 25th day of February, 2020 authorized the Hammond Police Department to apply to the Indiana Criminal Justice Institute for a 2020 Stop Arm Violation Enforcement (SAVE) Grant which is allocated for the purpose of providing assistance in the safe transportation of school age pedestrians at school bus locations; and

WHEREAS, the Hammond Police Department is a recipient of the 2020 SAVE Grant in the amount of \$24,000 and requires a dedicated fund to receipt and disburse this grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, Megan Flores, City Controller, requests that a new account, number 278, be dedicated and created for the City of Hammond Police Department for purposes of accessing funds for the 2020 SAVE Grant with the Revenue Account being 20-278-331.00 and the Budget Accounts being 20-278-41102-201 and 20-278-41301-201; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;


NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:




