ORDINANCE NO. 9487

**AN ORDINANCE FIXING THE SALARIES FOR ELECTED CITY OFFICIALS FOR THE CITY OF HAMMOND, INDIANA COMMENCING JANUARY 1, 2021**

WHEREAS, the Common Council of the City of Hammond desires to set the 2021 salary schedule for elected officials of the City of Hammond pursuant to IC 36-4-7-2.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond, Indiana as follows:

**SECTION ONE:** For the calendar year 2021, the salary schedule for elected officials of the City of Hammond, Indiana shall be fixed as follows:

MAYOR	89,301	Civil City
	16,236	Water Department
	16,236	Sanitary District
	16,236	Port Authority
CLERK	90,450	Civil City
COUNCILPERSONS	33,122	Civil City

**SECTION TWO:** For 2021, the paydays shall be every other Friday commencing on January 8<sup>th</sup>, 2021 for a total of 26 pays.

**SECTION THREE:** The City shall pay the 3% contribution in PERF for those officials who do not already participate in another retirement or pension plan supported in whole or in part by the State or political subdivision of the State, as of January 1, 1992.




