**AN ORDINANCE CREATING NEW FUNDS (FUNDS #229, #238, #280, #281) FOR JUSTICE ASSISTANCE GRANT (JAG) PROGRAM FUNDS AWARDED TO CITY OF HAMMOND POLICE DEPARTMENT**

WHEREAS, the Edward Byrne Justice Assistance Grant (JAG) Program, administered by the Bureau of Justice Assistance (BJA) provides states, territories, tribes, and local governments with critical funding necessary to support a range of law enforcement program areas; and

WHEREAS, the BJA has awarded the City of Hammond Police Department JAG funds for FY2017, FY2018, FY2019 and FY2020; and

WHEREAS, the City of Hammond Police Department requires the use of these monies received from the JAG Program which requires dedicated funds to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have new funds established for receipt and distribution of these funds; and

WHEREAS, Megan Flores, City Controller, requests that new accounts be dedicated and created for the City of Hammond for purposes of accessing funds for FY2017 through FY2020 JAG Program funds; and

WHEREAS, the creation of these funds are not additional appropriations and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create new accounts for the City of Hammond as follows:
