**AN ORDINANCE CREATING A NEW FUND (FUND #176) FOR THE FUNDS  
DISTRIBUTED TO THE CITY OF HAMMOND FROM THE AMERICAN RESCUE  
PLAN**

WHEREAS, President Biden signed the \$1.9 trillion American Rescue Plan (ARPA) in to law on March 11, 2021; and

WHEREAS, the ARPA includes \$350 billion dollars in direct, flexible aid to states, territories, tribes, cities, and counties; and

WHEREAS, the House Oversight Committee estimated the allocation of ARPA funds for the City of Hammond to be Fifty-Three Million Two Hundred Sixty-Seven Thousand Six Hundred Eighty Dollars and Three Cents (\$53,267,680.03); and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these ARPA funds; and

WHEREAS, Megan Flores, City Controller, requests that a new account, number 176, be dedicated and created for the City of Hammond for purposes of accessing funds for the 2021 American Rescue Plan funds with the following account numbers:

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:


CITY OF HAMMOND - THE AMERICAN RESCUE PLAN ARP FUND #176

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor and approval of the DLGF.




