**AN ORDINANCE CREATING A NEW FUND (FUND #246) AND TO APPROPRIATE FUNDS WITHIN THE HAMMOND POLICE DEPARTMENT GRANT FUND FOR 2021**

WHEREAS, Resolution No. 21R-12 adopted and approved by the Hammond Common Council authorized the Hammond Police Department to apply to the Indiana Criminal Justice Institute for a 2021 Stop Arm Violation Enforcement (SAVE) Grant which is allocated for the purpose of providing assistance in the safe transportation of school age pedestrians at school bus locations; and

WHEREAS, the Hammond Police Department is a recipient of the 2021 SAVE Grant in the amount of \$30,800; and

WHEREAS, the City of Hammond Police Department requires the use of monies received from the SAVE grant which requires creation of a Fund (#246) and an appropriation; and

WHEREAS, when these funds are available, they will be used for and appropriated to newly created fund #246; and

WHEREAS, this transaction, being an appropriation must have a public hearing for which the Clerk of the Common Council is hereby directed to make arrangement, and being subject to approval by the Department of Local Government Finance; and






