ORDINANCE NO. 9536

AN ORDINANCE AMENDING ORDINANCE NUMBERS 7685, 8200, 8564, 8630, 8645, 8718, 8754, 9755, 8854, 8930, 9017, 9061, 9194, 9252, 9359, 9375, 9462 and 9470 ALSO KNOWN AS SECTION 36.005 OF THE HAMMOND MUNICIPAL CODE, PERTAINING TO HAMMOND IS MY HOME ELIGIBLE IMPROVEMENT PROJECTS

WHEREAS, Ordinances 7685, 8200, 8564, 8630, 8645, 8718, 8754, 9755, 8854, 8930, 9017, 9061, 9194, 9252, 9359, 9375, 9462 and 9470 also known as Section 36.005 of the Hammond Municipal Code pertains to the expenditure, use, and distributions of Hammond's revenue from riverboat gambling; and

WHEREAS, Section 36.005(B)(2) provides that gross gaming revenue shall be reduced to meet the obligation of an identified list of city-sponsored community projects, including the Hammond is My Home Project (see §36.005(B)(2)(j)); and

WHEREAS, previous Ordinance No. 9359 established the Hammond is My Home program which provides grant monies to Hammond homeowners, as demonstrated by a current and valid homestead exemption, who are permanently displaced by the following City of Hammond improvement projects: Linden Retention Pond project, Chicago Avenue Street reconstruction project, and West Lake Corridor project; and

WHEREAS, it is the will of the Hammond City Council to add the Governor's Parkway Project to the list of eligible Hammond is My Home improvement projects; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond, Indiana that Ordinances 7685, 8200, 8564, 8630, 8645, 8718, 8754, 9755, 8854, 8930, 9017, 9061, 9194, 9252, 9359, 9375, 9462 and 9470 the same being known as Section 36.005 of the Hammond Municipal Code Ordinance Number 7598, 8348, 8753, 9161, and 9357, the same being known as Section 93.005 of the Hammond Municipal Code is amended to alter §36.005(B)(2)(j) to include the Governor's Parkway Project as an eligible Hammond is My Home improvement project.

THEREFORE, BE IT FURTHER ORDAINED that if any part of this ordinance shall be held invalid by a court of competent jurisdiction, the remainder thereof shall not be affected.


BE IT FURTHER ORDAINED this Ordinance shall be considered as amending Section 36005(B)(2)(j) of the Hammond Municipal Code as to the addition of the Governor's Parkway Project as an eligible Hammond is My Home improvement project, and if there be any conflict therewith with any other section, this Amended ordinance shall take precedence.

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof, and approval by the Mayor.


