**AN ORDINANCE TRANSFERRING DORMANT FUND BALANCES TO THE  
GENERAL FUND**

**WHEREAS**, the Common Council of the City of Hammond, Indiana, is responsible for the performance of various functions for the City of Hammond (the "City"); and

**WHEREAS**, the City has identified non-tax levied funds that are considered to be dormant; and

**WHEREAS**, the City currently has unused and unencumbered balances remaining in the following funds:

- 011- Graffiti Removal
- 200- Public Defender
- 218- Drug Free LK CT
- 273- Tobacco Ed/Judg
- 404- Major Moves
- 503- Cost Due County
- 505- Deferral Program
- 507- Local Infraction Defer

**WHEREAS**, the Common Council now desires to transfer the remaining balances of the aforementioned funds to the City's General Fund.

**THEREFORE BE IT ORDAINED** by the Common Council of the City of Hammond, Indiana, that this Ordinance Transferring Dormant Fund Balances to the City of Hammond General Fund, is hereby adopted as follows:

- 1. Transfer.** The following funds shall be closed, and the remaining listed balances shall be transferred to the General Fund:




