ORDINANCE NO. 9558

**AN ORDINANCE CREATING NEW FUND (FUND #2468) FOR THE CITY OF
HAMMOND POLICE DEPARTMENT FOR FY2021 BULLETPROOF VEST GRANT
(BPV) FUNDS**

WHEREAS, the Patrick Leahy Bulletproof Vest Partnership, created by the Bulletproof Vest Partnership Grant Act of 1998 is a U.S. Department of Justice initiative offering grant money to local law enforcement agencies for body armor purchases; and

WHEREAS, the Hammond Police Department is a recipient of Bulletproof Vest Grant (BPV) and requires a dedicated fund to receipt and disburse this grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account, number 2468, be dedicated and created for the City of Hammond Police Department for purposes of accessing funds for the 2021 Bulletproof Vests Grant with Revenue Account line item being 331.00 and Budget Account line item being 429.01 (frontline supplies); and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;


NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:




