ORDINANCE NO. 9559

**AN ORDINANCE CREATING NEW FUND (FUND #2469) FOR THE CITY OF HAMMOND FIRE DEPARTMENT FOR FY2022 WALMART GRANT FUNDS**

WHEREAS, local community grants are provided directly by Walmart to local organizations for community and economic development, diversity and inclusion, education, environmental sustainability, health and human service, hunger relief, public safety, and quality of life; and

WHEREAS, the Hammond Fire Department is the recipient of a 2022 Walmart Community Grant for the purpose of training programs and equipment for first responders and requires a dedicated fund to receipt and disburse this grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account, number 2469, be dedicated and created for the City of Hammond Fire Department for purposes of accessing funds for the 2022 Walmart Grant with Revenue Account line item being 331.00 and Budget Account line item being 429.01 (frontline supplies); and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:






