ORDINANCE NO. 9568

**AN ORDINANCE AMENDING §99.65 OF THE HAMMOND MUNICIPAL CODE,  
PERTAINING TO PARK TRAFFIC RULES**

WHEREAS, Section 99.65 of the Hammond Municipal Code (HMC) currently prohibits vehicle parking in or along any park or park street under the jurisdiction of the Board of Park Commissioners between the hours of 2:00 a.m. and 6:00 a.m.; and

WHEREAS, to maintain uniformity with signage posted along park streets and to ensure the safety and wellbeing of Hammond residents and visitors to city parks, Section 99.65 of the HMC must be amended; and

WHEREAS, the Common Council of the City of Hammond now wishes to amend Section 99.65 of the Hammond Municipal Code to prohibit parking along any park or park street from dusk until dawn, unless otherwise restricted by police order or resolution or action taken by the Board of Park Commissioners; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond, Indiana that Section 99.65 of the HMC, be amended to read as follows:

**§99.65 PARKING PROHIBITED.**

**No person shall, between dusk and dawn, park a vehicle in or along any park or park street, except those persons participating in programs approved by the city or Board of Park Commissioners.**


**These hours may otherwise be restricted by police order, Board of Park Commissioners resolution, or action by way of posting signage clearly indicating a restricted date and time.**


