ORDINANCE NO. 9569

**AN ORDINANCE AMENDING ORDINANCE 7554, ORDINANCE 8452,  
AND ORDINANCE 9168 AS IT PERTAINS TO COUNCILMANIC DISTRICTS  
IN SECOND CLASS CITIES**

WHEREAS, Section 36-4-6-3 of the Indiana Code regulates the adoption of Ordinances by Second Class Cities to divide that City into Councilmanic Districts; and

WHEREAS, Indiana Code 36-4-6-3(g) and Indiana Code 3-5-10-7 requires that an Ordinance be passed during the second year after a year in which a federal decennial census is conducted; and

WHEREAS, In accordance with State Law, Ordinance 7554 was passed in December 1992, Ordinance 8452 was passed in October 2002, and Ordinance 9168 was passed in August, 2012 and it is now required in 2022 that a new Ordinance be passed; and

WHEREAS, a study of the current federal census populations of the Councilmanic districts of Hammond, a Second Class City, are comprised of contiguous territory, reasonably compact, do not cross precinct boundaries, and are, as nearly as possible, of equal population, taking into consideration the census and knowledge of the city and its population and growth; and

WHEREAS, since the last redistricting in 2012 there has been, by order of the Indiana legislature and Secretary of State, consolidation of precincts within the city, but said consolidation has not crossed councilmanic districts, leaving all district precincts within their respective councilmanic districts; and

WHEREAS, after due consideration the City of Hammond Common Council has determined that a redistricting is not required at this time and therefore this ordinance shall pursuant to Indiana Code 36-4-6-3(j) recertify that the districts as currently drawn comply with Indiana Code 36-4-6-3 and therefore the City of Hammond by its Common Council now recertifies the following six districts;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that:

The City of Hammond is hereby divided into six (6) districts as follows:


- (A) The first district shall be composed of the following precincts, as now established: H1-01; H1-03; H1-05; H1-07; H1-08; H1-10; H1-12; H1-16;
- (B) The second district shall be composed of the following precincts, as now established: H2-03; H2-05; H2-06; H2-11; H2-12; H2-14;
- (C) The third district shall be composed of the following precincts, as now established: H3-03; H3-04; H3-05; H3-07; H3-09; H3-11; H3-16;
- (D) The fourth district shall be composed of the following precincts, as now established: H4-05; H4-06; H4-07; H4-09; H4-11; H4-12; H4-14; H4-18;
- (E) The fifth district shall be composed of the following precincts, as now established: H5-04; H5-08; H5-12; H5-13; H5-14; H5-15; H5-17
- (F) The sixth district shall be composed of the following precincts, as now established: H6-04; H6-05; H6-07; H6-08; H6-09; H6-10; H6-12; H6-13; H6-15;

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof, and approval by the Mayor.


