**AN ORDINANCE TO APPROPRIATE UNSPENT MONIES INTO THE 2022 AMERICAN RESCUE PLAN FUND 2410 FROM 2021 PREVIOUSLY APPROPRIATED AMERICAN RESCUE PLAN FUNDS**

WHEREAS, the City of Hammond Department adopted Ordinance 9516 on September 29, 2021 appropriating the American Rescue Plan Act funds to various accounts for approved expenses as described in Resolution 21R-25; and

WHEREAS, additional unspent monies remain from 2021 appropriated balances and require appropriation in the current fiscal year; and

WHEREAS, unspent American Rescue Plan Act funds will continue to be allocated for those projects pursuant to the City Council’s prior actions; and

WHEREAS, this transaction, being an appropriation must have a public hearing for which the Clerk of the Common Council is hereby directed to make arrangements, and being subject to approval of the Department of Local Government Finance.






