**AN ORDINANCE CREATING A NEW FUND (FUND #2472) FOR JUSTICE ASSISTANCE GRANT (JAG) PROGRAM FUNDS AWARDED TO CITY OF HAMMOND POLICE DEPARTMENT**

WHEREAS, the Edward Byrne Justice Assistance Grant (JAG) Program, administered by the Bureau of Justice Assistance (BJA) provides states, territories, tribes, and local governments with critical funding necessary to support a range of law enforcement program areas; and

WHEREAS, after successful application to the JAG program, the BJA has awarded the City of Hammond Police Department JAG funds for FY2021; and

WHEREAS, the City of Hammond Police Department requires the use of these monies received from the JAG Program which requires a dedicated fund to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account be dedicated and created for the City of Hammond for purposes of accessing funds for FY2021 JAG Program; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:


