ORDINANCE NO. 9597

AN ORDINANCE AMENDING FUND NUMBER FOR FY2021 JUSTICE ASSISTANCE GRANT (JAG) PROGRAM FUNDS AWARDED TO CITY OF HAMMOND POLICE DEPARTMENT

WHEREAS, Ordinance No. 9582 creating Fund #2472 for FY2021 Justice Assistance Grant Program Funds was adopted and approved by the Hammond Common Council on December 12, 2022; and

WHEREAS, a duplicative Fund #2472 was then subsequently dedicated for use of FY2023 SAVE grant funds; and

WHEREAS, the City of Hammond Police Department still requires a dedicated fund to receipt and disburse the allocation of FY2021 JAG program monies; and

WHEREAS, the City of Hammond must now amend the fund number established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that the previously dedicated fund number (Fund #2472) be amended to that of Fund #2475 for purposes of accessing funds for FY2021 JAG Program; and

WHEREAS, the amendment of this fund number is not an additional appropriation and a public hearing is not required;


