**2016 APPROPRIATION REDUCTION RESOLUTION**

WHEREAS, the Department of Local Government and Finance instructs political subdivisions to handle reductions of appropriations in the same manner as additional appropriations; and

WHEREAS, appropriation reductions in the current year have the effect of increasing fund balances available in the ensuing year; and

WHEREAS, it has been shown that certain existing appropriations now have unobligated balances that will not be needed for the purposes for which appropriated; and
