RESOLUTION NO. R34

A RESOLUTION AUTHORIZING THE HAMMOND FIRE DEPARTMENT TO APPLY FOR THE 2017 ASSISTANCE TO FIREFIGHTER (AFG) GRANT FOR MDT'S

WHEREAS, the Hammond Fire Department, wishes to modernize its ambulances and fire vehicles with the addition of mobile data terminals (MDTs) similar to those found in police cars; and

WHEREAS; currently a regional 2017 Assistance to firefighters (AFC) regional grant is available from the Federal Emergency Management Agency (FEMA) which allows regional participation of Lake County fire agencies; and

WHEREAS, this regional grant, if awarded to all Lake County Fire Departments, would cover \$30,000.00 of the cost of MDTs for Hammond vehicles, which would be Hammond's share of the grant; and

WHEREAS, the City of Hammond must apply for to be awarded these AFG grant funds and the Hammond Fire Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the Hammond Fire Department be authorized to apply for 2017 AFG Grant for the purpose of purchasing mobile data terminals (MDTs).

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
