A RESOLUTION AUTHORIZING THE CITY OF HAMMOND, BY THE HAMMOND BOARD OF PUBLIC WORKS TO ENTER A LEASE AGREEMENT FOR A FIRETRUCK

WHEREAS, the Hammond Fire Department, due to age and wear and tear, needs new emergency service vehicle to be used for public safety; and

WHEREAS; the City of Hammond, by its Fire Department, has an opportunity to enter into a Governmental Leas Purchase Agreement with Wells Fargo Equipment Finance, Inc., and

WHEREAS, a E-1 fire Truck Vehicles are available for lease from Fire Service, Inc., with lease financing available through Wells Fargo Equipment Finance, Inc.; and

WHEREAS, the City of Hammond and the Hammond Fire Department request the Approval and Ratification of the Hammond Common Council for this lease agreement; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the City of Hammond, by and through the Hammond Fire Department is authorized to purchase through a lease agreement one 2017 E-One 100' Metro Qunit Ladder Truck, VIN# 4EN6ABA80H1000982 together with all attachments and accessories, with a payment term of 48 Months for a total of \$896,767.20.

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
