WHEREAS, The Indiana Criminal Justice Institute (ICJI) annually offers traffic safety grant money to local law enforcement agencies; and

WHEREAS; currently a grant is available for the Hammond Police Department, the Pedestrian and Bicycle Safety Grant in the amount of \$12,500.00.

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant; and

WHEREAS, the City of Hammond must apply for to be awarded these grant funds and the Hammond Police Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the Hammond Police Department be authorized to apply to the ICJI for a 2019 grant for the purpose of traffic safety programs.

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
