WHEREAS, Roosevelt Moore Jr. was born to Patricia Moore and Roosevelt Moore Sr. on March 18, 1982; and

WHEREAS, Roosevelt is a lifelong member of New Community Baptist Church and a product of the School City of Hammond and graduated as a successful student athlete from Hammond High School in 2001 after participating in football, baseball and yearbook; and

WHEREAS, he then went on to graduate from Lakeland University in Plymouth, Wisconsin with a major in Sociology and an emphasis in Criminal Justice, where he also played linebacker for the Lakeland University Football Team; and

WHEREAS, while a member of the Lakeland University Football Team he went on to a 23-17 record (19-11 as a starter) and was named as the Scout Team Player of the Year (2000), Linebacker of the Year (2 years), All Conference Linebacker (3 years), and Defensive Player of the Year (2003); and

WHEREAS, since 2004 he has served as an assistant and then head football coach, an assistant track coach, and the assistant athletic director; and


WHEREAS, he received his teaching certificate from Indiana University Northwest and since 2006 has taught as an educator at Morton High School and then at Hammond High School in the Special Education and Health Departments; and
