**A RESOLUTION AUTHORIZING THE HAMMOND POLICE DEPARTMENT TO  
APPLY FOR THE FY2020 CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING  
PROGRAM**

WHEREAS, The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance (BJA) has made funds available to assist eligible states and local units of government with respect to addressing the Coronavirus pandemic; and

WHEREAS; currently a grant is available for the Hammond Police Department through the Coronavirus Emergency Supplemental Funding (CESF) program, which is allocated for the purpose of preventing, preparing for, and responding to the Coronavirus; and

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant which is being requested in the amount of \$147,269.00; and

WHEREAS, the City of Hammond must apply to be awarded these grant funds and the Hammond Police Department wishes to make this CESF Grant Application and requires the Approval of the Hammond Common Council; and


