WHEREAS, On April 8, 2021, The Office of Community Planning and Development's (CPD) Fiscal Year (FY) 2021 HOME Investment Partnerships Program-American Rescue Plan HOME-ARP formula allocations; and

WHEREAS, HOME-ARP provides \$5 billion to assist individuals or households who are homeless, at risk of homelessness, and other vulnerable populations, by providing housing, rental assistance, supportive services, and non-congregate shelter, to reduce homelessness and increase housing stability across the country

WHEREAS, the HOME-ARP made available an allocation of HOME Investment Partnerships (HOME) Program for the City of Hammond in amount of \$1,765,004; and

The United States of America and the Secretary of the U.S. Department of Housing and Urban Development be, and hereby are, assured of full compliance and administration of Civil Rights Act, citizen participation, equal opportunity, relocation payments, affirmative action, acquisition processes, accounting processes, the Hatch Act, minimum wage and minimum hours provisions of the Fair Labor Standard Act, and requirements of the National Environmental Policy Act of 1968.
2. The Mayor of the City of Hammond, Indiana is authorized and directed to prepare an application for the FY2021 HOME Investment Partnership grant and to execute the proposed HOME-ARP program including all understandings and assurances contained herein as provided in this Resolution.




