A RESOLUTION AUTHORIZING THE HAMMOND FIRE DEPARTMENT TO APPLY FOR A 2021 FIREHOUSE SUBS PUBLIC SAFETY GRANT (FHSUB GRANT 21)

WHEREAS, the Firehouse Subs Foundation offers a Firehouse Subs Public Safety Grant (FHSUB Grant 21) to provide lifesaving equipment and prevention education tools to first responders and public safety organizations; and

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant which is being requested in the amount of \$29,717.00; and


WHEREAS, the City of Hammond must complete an application in order to be awarded the requested grant funds and the Hammond Fire Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the Hammond Fire Department be authorized to apply to the Firehouse Subs Foundation for a FHSUB Grant 21 for the purpose of providing lifesaving equipment and prevention education tools; and

BE IT FUTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof, and approval by the Mayor.




