WHEREAS, the Edward Byrne Justice Assistance Grant (JAG) Program, administered by the Bureau of Justice Assistance (BJA) provides states, territories, tribes, and local governments with critical funding necessary to support a range of law enforcement program areas; and

WHEREAS, this Grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant, which is being requested in the amount of \$30,390.36; and

WHEREAS, the City of Hammond must apply for the FY2021 JAG to be awarded these grant funds and the Hammond Police Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and


