**A RESOLUTION AUTHORIZING THE HAMMOND FIRE DEPARTMENT TO APPLY FOR
A 2021 NIPSCO PUBLIC SAFETY EDUCATION AND TRAINING ACTION GRANT**

WHEREAS, The Northern Indiana Public Service Company (NIPSCO) annually offers public safety education grant money to local public safety agencies; and

WHEREAS; currently a grant is available for the Hammond Fire Department through the Public Safety Education and Training Action (2021 NIPSCO Safety Grant) program, which is allocated for the purpose of providing community and youth public safety education programming and training for first responders; and

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant which is being requested in the amount of \$5,000; and

WHEREAS, the City of Hammond must apply to be awarded these grant funds and the Hammond Fire Department wishes to make this 2021 NIPSCO Safety Grant Application and requires the Approval of the Hammond Common Council; and






