**A RESOLUTION AUTHORIZING THE HAMMOND POLICE DEPARTMENT TO  
APPLY FOR A 2021 BULLETPROOF VEST GRANT**

WHEREAS, the Patrick Leahy Bulletproof Vest Partnership, created by the Bulletproof Vest Partnership Grant Act of 1998 is a U.S. Department of Justice initiative offering grant money to local law enforcement agencies for body armor purchases; and

WHEREAS, currently a grant is available for the Hammond Police Department, through the program, in the amount of \$22,500.00 for the purchase of bulletproof vests; and

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant; and

WHEREAS, the City of Hammond must complete an application in order to be awarded the requested grant funds and the Hammond Police Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and






