

ORDINANCE NUMBER 7619

AN ORDINANCE TO AMEND SECTION 97.11 (H) OF THE CODE OF ORDINANCES OF THE CITY OF HAMMOND TO PROHIBIT THE OPERATION OF LAWNMOWERS BETWEEN THE HOURS OF 9:00 P.M. AND 7:00 A.M.

(As Amended)

WHEREAS, the Common Council of the City of Hammond finds that the operation of power LAWNMOWERS between the hours of 9:00 p.m. and 7:00 a.m. may cause noise disturbances and therefore should be included in the acts prohibited by Section 97.11 (H) of the Code of Ordinances of the City of Hammond, and;

THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND as follows:

Section 1. That Section 97.11 (H) of the Code of Ordinances of the City of Hammond shall be amended by substituted to read as follows:

"(H) Operating or Permitting the Operation of Powered Model Vehicles or Power LAWNMOWERS Between the Hours of 9:00 p.m. and 7:00 a.m. the following Morning, in a Manner as to Cause a Noise Disturbance."

Section 2. This ordinance shall become effective upon its passage by the Common Council, signing by its President, the approval of the Mayor, or the override of the Mayor's veto, and by its publication as provided by law.
