

The regular meeting of the Hammond Common Council of the City of Hammond, Lake County, Indiana was held on March 28, 2022 in the Hammond City Council Chambers and was available to be viewed at gohammond on Facebook, gohammond.tv live and per Zoom.

Council President Dave Woerpel presided.

Council Coordinator Assistant Darrell White facilitated.

MAYOR'S ADDRESS

Corporation Counsel Kevin Smith - Obviously, you got third string here tonight. Phil is on vacation and the Mayor had a conflict. But he wanted me to make sure that you all knew that either myself or Phil or he will always be here to give a report. So I went over several things this morning to make sure that my report was as thorough as possible. So I'll go through those items and hope to be very quick. The Mayor met with the utilities, namely the Hammond Water Works and Sanitary District regarding the budgetary impacts of their pilot payments and whether or not they could meet their obligations based upon the increased costs they are facing. For example, I learned today that the cost chemicals has quadrupled at the Water Works and similarly at the Sanitary District. So between increased costs of goods, increased cost of labor, bids that are going out are increased as well, 7% inflation, the war in Ukraine, etc., all impacting costs at our utilities. The assumptions that regarding the pilot payments were built into the budget, however the changes in the world are starting to wreak havoc on those budgets and I know that Megan and her staff is monitoring the situation but the Mayor at least wanted me to let you know that is potentially impacting the pilot payments that were budgeted for both Hammond Water Works and the Sanitary District. Some good news to report, both Hohman Avenue reconstruct, from Sibley to Russell, and the Kennedy Avenue Downtown project, construction will be starting next week on both projects. As you know, ARP funds are being sued for both of the projects, \$5 million each. Fire Station #2 update, plans are at 90% and that project will go to bid this spring and we look forward to a new Fire Station up in, serving the norther part of our city, specifically Robertsdale and North Hammond. Just approved through the Board of Works is to go to bid for phase 2 of the Robertsdale Lead Remediation Project. That will include thirty properties. The bid is set for April and that work will be completed in 2022. It will take us to approximately forty seven properties remediated. I know that the seventeen property owners, some of those were doubles, so it probably wasn't seventeen letters, it was probably like fourteen letters. Because some people own two properties. Those letters went out along with the recorded certificates on those properties. That was real exciting to see those go out and to have that actually recorded on those properties and that the City was able to give that relief to those residents in a much quicker manner than what would have happened through the State

Corporation Counsel Smith cont. - or the Federal Government. We had a very lively Mayor's Night Out in the 1st District, so I want to thank everybody that went to that. I thought that was an interesting discussion. I want to thank Lost Marsh and the Port Authority and all the folks up there that put that on. There was a very exciting meeting with Councilman Tyler at City Hall with Economic Development and Redevelopment and the result of that is there is gonna be a RFP for the Redevelopment of, well, we can just look out the window here, from here to Eaton, those buildings that are left are gonna be demolished soon. And then also from Highland Street parking lot to the bar, which I think is Good Time Charlie's, those are all city owned. Ann is here and Africa and their department have been working very hard on getting that FRP so we're looking forward to developers for commercial development right here on Calumet Avenue, which is really exciting. It also may change a little bit of parking along Highland and along Lyons here that will open up some additional parking. Maybe some angle parking and things like that, some parallel parking up on Highland. I know our City Planner, Mr. Poland, is working with Mr. Button, our City Engineer on those plans. So that's exciting and we look forward to hopefully some development that will provide commercial, right here on Calumet Avenue across from the new high school and right next to City hall. The Mayor wanted me to mention that the call out right now for folks with a CDL is huge. There are jobs available for hire with the city if you have a CDL. The pay is over \$20 an hour or approximately \$20 an hour. You get, of course, fourteen holidays, health, dental, vision and pension benefits and many overtime opportunities. So anyone that is either listening on Facebook, or is hearing this when it is recorded, or even just in the room now, if you know anyone with a CDL, please have them contact Sharon Daniels of Personnel so she could get their resume in and their application because there are jobs available and good jobs with good benefits. The ATG tax abatement is before you tonight and the Mayor wanted me to mention that the administration is fully supportive of it and it looks forward to Eric Gastevich And his team building a phenomenal project in Downtown Hammond and bringing people back to live Downtown and to make that a vibrant place that we all believe it should be and that it will be after some time and some significant investment. And so we believe that the tax abatement that is being requested by Mr. Gastevich and his team is appropriate and the administration fully supports it and would request the Council to support it tonight. The Mayor met with both Police and Fire Departments to figure out how to get I guess, these are important points for the Mayor. One, to make sure that we maintain it and increase a diverse workforce. Two, to have the best candidates apply so that we are competitive throughout the other municipalities in Lake County, including the County. So we are working on ways to do that, including increasing probationary Fire and Police pay and also removing the one year requirement for residency which is before you tonight among other things. So, there are the Police, I believe have estimated somewhere between fifteen and thirty police officers could retire in the next two to three years and so you can look at that two ways, glass half full or glass half empty. Glass half empty, we're losing some very veteran police officers. Glass half full, it allows folks that are in the middle area to move up and it allows some young men and women to become police officers in our great city. So, again, I would encourage any young person that you may know to apply to become a firefighter or a police officer in the City of Hammond. The Disabilities Breakfast was well attended and well organized and a thank you goes out to the Disabilities Commission for their continued fine, hard work and commitment to those members of our community with disabilities. Highlighting the work that is being done in the community has always been important to the City and I think the City has been at the forefront of that issue for some time. The Mayor was excited to announce that Toby Keith will be playing for Festival of the Lakes on Wednesday night. VIP Experience passes are available right now on festivalofthelakes.com and he also wanted the Council and the

Corporation Council Smith cont. - public to know that the City is very close with four of the five nights being done. We can't quite announce them yet but we're getting close on those announcements and it's gonna be another great and fabulous Festival of the Lakes. We always seem every year to say this is our best one and then every year it's another best one. So, I know that Aileen and Jill and others are working very hard, the whole Committee is working hard to make sure to bring you the best festival and bring the Region the best festival so they get to come to Hammond and see what we have here at Wolf Lake. Lastly, I did want to mention, and I saw Ruth Mores here tonight. The City has met with Mike Nolan and NICTD regarding the South Hammond parking lot and the concerns that we have regarding the size of that lot and the impact that will have in the 4th District and in that neighborhood. So I wanted the Council to know that it is an important issue for the administration and it knows that it's an important issue to that neighborhood and to South Hammond. Dean Button and the City Engineering Department is working with a consultant that will continue to press that issue with both NICTD and beyond and we believe that Mr. Nolan and his crew came to City Hall, I think, with open minds and are looking for a solution that is both consistent with their application to the Federal Government and yet can take into consideration the concerns of the residents in that part of the city. That's all I have, Mr. President. Thank you for your time and thank you to the Council for their time. I'll entertain any questions if there are any.

Councilwoman Venecz - With regard to the parking lot in South Hammond for the train project, there have not been any ... I know that there are meetings with the administration and NICTD and all that but I've gotten some calls and I'm sure Councilman Emerson has too with regard to updating the neighborhood on what's going on. Because obviously everyone knows that the neighborhood is opposed to the size of the parking lot that they're proposing. So I guess my suggestion would be to update the neighborhood. Have a meeting with the neighborhood so the residents can come out and ask questions and voice their opinion and concerns.

Corporation Council Smith - I think that's a great idea, Councilwoman Venecz, and I will take it back to the Mayor and to NICTD. I know that Mr. Button would be there as well as Mr. Poland and other people from the administration would be happy to report at least what we know. I can tell you that the mantra that we keep hearing from NICTD is well this is what the application was approved, and as much as we understand that we're still pushing back and we're not just gonna take that as the only answer. So we want to work with them but we also don't want to ... we want them to understand that this is a serious issue, because it is to the neighborhood.

Councilwoman Venecz - Absolutely, thank you.

Councilman Emerson - At the meeting with NICTD I felt that all along traffic has been a consideration for me and if you go to 173rd and Calumet or if you go to even Hohman Avenue at rush hour in the morning and in the evening it's an issue right now and having a 600 car parking lot, if that's the final number they agree on, I don't see how that ... I brought that up early on like four years ago, I think, and they said, "oh, we studied the traffic and it's not going to be a problem". I think it is a problem right now at 173rd and Calumet with Walgreen's and Duncan Donuts and but I would support a community meeting if NICTD wants to do that I'll try to be there certainly because I know it's an issue. Ninety per cent of the people that call me don't want the station there. They're okay with the train but they don't want the station. But, be that as it may ... I did have a question, Mr.

Councilman Emerson cont. - President, early on you talked about Water Works and Sanitation and it's impact on the budget. Could you elaborate on that?

Corporation Council Smith - Sure, I believe there was a pilot payment, so payment in leu of taxes, payment that was in the budget. Megan, that's accurate, right? Yes, okay. And so that's a payment that they make annually since they don't pay taxes. It's based upon the amount of property that they own and last year, I believe, we had a consultant do an analysis, maybe it was two years ago, to give the real, hopefully, as close to a good number that they should be paying because they don't pay taxes, right, because they are a utility. So we tried to work that number into the budget and the point I was trying to make, Councilman Emerson, was that because of some other, at least at the time, unknown increases in other things that the Sanitary District, that's impacting their ability to potentially make that full number which, of course, would impact the City Budget. So it's not like the alarm is being sounded fully yet. It's more of a heads up. We're only in March and they're already saying, Hey, we can't believe how much this is costing us." Not the pilot payment but the chemicals, fuel, you know, on and on. So those were unforeseen circumstances, I think nobody expected inflation to be what it is. Nobody expected a war in Ukraine to affect gas the way it is or to even there to be a war in Ukraine. So that was the point I was trying to make.

Councilman Kalwinski - So what is the number in leu of taxes right now?

Corporation Council Smith - Couldn't tell ya. I don't have the budget with me. I'm sorry, I just don't have that at my fingertips.

Council President Woerpel- So noted.

COMMITTEE REPORTS

Capital Improvement Board - Councilwoman Venecz - We met on March 21st, 2022. We approved \$25,000 for Hammond Consultant Support Related to NITCD Westlake Project. This is with regard to South Hammond parking upon the Gateway location. We approved \$25,875.00 for Engineering Services to perform the Paser Rating Inspection by Nies Eng. Come to find out that is Pavement Service and Rating System. It's required by INDOT. And again, that's \$25,875.00. We also approved \$1 million for the 2022 Overlay program and the streets have been evaluated and there is a list available. We also approved \$59,750 for drainage improvements at 52 169th Street. This is a federal highway project in cooperation with NIRPC and it is an 80|20 split. We also approved \$17,462.24, this is for the Michigan/Indianapolis Retaining Wall Design. We also approved \$53,350. This is for the right of way acquisition at Michigan Street and Indianapolis Blvd. That was an agreement that was made when Lear, was that the name? Came in there to alleviate some of the traffic. And also with regard to Councilman Torres and the communication that he sent to the Capital Improvement Board. I just wanted to thank him for coming before the board. I think that he got answers, u. Um, immediate answers for some of the projects that he is looking to accomplish. Some of them are not too promising. Uh, and unless we get some huge funding somewhere along the line. But I thank you, Councilman Torres, for at least being willing to come before the board and find out what's going on with some of the projects that you are interested in accomplishing.

Councilman Rakos, supported by Councilwoman Venecz, moved for final passage.

Councilman Rakos- In the past police and fire had to maintain residency for the first year. And as it states in the ordinance, this is due to the competitive salaries and benefits of police and fire departments in nearby communities. The City of Hammond must make changes in order to maintain a strong and diverse police and fire workforce. And they want to eliminate the one year residency for sworn, Hammond Police, and Fire.

Councilman Kalwinski- I can appreciate the fire and police chief's frustration with getting numbers up there for hires in the City of Hammond. I just would prefer that they don't take the residency and that maybe this is an opportunity to really look at Hammond and aggressively try again to go after Hammond residents who might be interested. We have 70,000 residents. People who need jobs. I know the pandemic scared people away from work and they're slowing coming back. But I'm willing to have the departments go after employees from the City of Hammond and concentrate on that. And if they're not going to do that, this residency is going to be discarded. I would think that maybe we should look at why is Hammond not an appealing place to move to but also perhaps we should look at Academy Bound and the training for new EMTs that want to work in the City of Hammond, and maybe those programs should be discontinued if there's no incentive to live here and in order... If living in Hammond doesn't help people get a free education, we really have to look at what else is there to incent them to be a part of Hammond versus getting rid of residency. Thank you.

Councilwoman Alexander-I would just hope that as we're deciding on this, that as police and fire are doing their evaluations going through all of their processes, and they're always looking at our Hammond Residents first in accordance with other residents from other areas to get the exact number that they're looking for. I'm pretty sure both chiefs are doing a good job with that. That they are vetting our Hammond residents as well as trying to get those others to participate or to get hired, but we do know that in this pandemic it has been extremely hard. Um, between people retiring, things like that, and they're trying to get a certain number and I know we can go back and we can look at bringing this back once again, at a proper time after. You know, we go ahead and make our decision today.


