## MAYOR'S ADDRESS

Mayor McDermott - Good to see everybody, welcome back. I missed the last meeting. The Chief of Staff, Phil Taillon gave the message from the Mayor and I read over the meeting minutes and Phil mentioned a couple things I wanted to reiterate on so my reports going to be a little bit longer, it won't be too long. Last meeting Phil mentioned the accomplishments of the Capital Improvements Board. I sent all of you a copy of the Capital Improvements Board Cumulative Summary. You should have all received that before the last meeting. To summarize, $\$ 16$ million in multi-district expensive projects were approved by the Capital Improvements Board up through last year. Projects that were hard to finance with our old system of distributing gaming moneys. I'm very proud of that. Phil also mentioned that the system wasn't perfect, and I agree with that as well. It's a new thing we started and, you know, obviously, some times you don't work things out perfectly the first time. So, if there are suggestions on how to make Capital Improvements Board better, I'm all ears. So, thank you. I wanted to point that out. Phil also mentioned the Gaming Advisory Committee has recently donated $\$ 520$ thousand in not-for-profits, mostly not-for-profits located in the city of Hammond. We went back and tallied all of the gaming money that we have distributed since I've been Mayor, going all the way back to 2004. We've given $\$ 11$ million out to not-for-profits in the last twenty years. Which these are great not-for-profits in our city that help a lot of people. I'm very proud of that. Last but not least, I wanted to point something out for Councilman Tyler, he was very instrumental in insuring that we created a rainy day account. It was something that he was talking about a lot when he first became a councilman. We created the rainy day fund when we created the Capital Improvement Board along with the Gaming Advisory Committee. I'm happy to report that we have $\$ 1.4$ million in the rainy day fund sitting there just collecting interest. So that's great news. So I think we should all be very proud of ourselves when you think about in the last four years what we've done. We've changed the way we do finances in the city of Hammond. I know a number of you mentioned that during your campaigns. That we spend money that we only have instead of spending money that we anticipate and that in itself was huge and quite frankly if we didn't do that we'd be experiencing a lot of trouble right now because Horseshoe Casino's gaming revenues have been down pretty dramatically over the last year. Under our old system it would have taken us a year to react to that. Over the last few weeks I've attended, on behalf of the city, Anti-Semitism

Mayor McDermott cont. - training with region political leaders and numerous law enforcement officials at the temple in Munster. It was put on by the Jewish Federation of NW Indiana. I attended along with Chief Andy Short and Chief Jeff Long. Attended the funeral of Rajesh Bhagwandeen, who is the young man who was murdered on $165^{\text {th }}$ Street in Hammond. I attended that with Chief Long and Chief Short. That was a road rage incident, very tragic. Attended the Lake County Community Advancement meeting featuring Hal Slager with my Economic Development team. Also, with the Economic Development team attended the ICSC Conference in Las Vegas, along with the Redevelopment Commission as well. MLK Park is open. Up and running, very proud. Everything has gone very well so far. The parking is working very well.
So it's been a very positive experience so far. We opened it on May 6. We held a press conference, myself, Councilman Tyler, Councilwoman Alexander were in attendance. Chief Short, Pastor Polk, Coach Larry Moore from Hammond Central basketball team was there. I think we all impressed upon the people using the park that we need to take care of this park better and let's just hope everybody is listening and it keeps on being a great place that it always has been. Megan gave me an update about the new software system that's going in. In 2021 we all committed to purchasing new financial and permitting software. Our previous system was over 30 years old. So you could imagine it was fairly out of date by that time. I think we were still using dos when I took over as Mayor. The new software is called Tyler Technologies. It is being implemented in three different phases. The finance portion concluded on May $1^{\text {st }}$ and the city is now live for accounts payable and accounts receivable. Which was a big first step. This took a couple years to get ready for. Second phase is focused on the permitting and licensing, which starts in mid May. The third phase focuses on HR and payroll. This phase is set to begin in late June. The new software will make operations more efficient for both city employees as well as the general public. The Sanitary District and the Water Department are also in the process of moving to the same software. So, for the first time in over three decades we've upgraded our software system and it'll affect show we do business and how the public does business with us. I want to congratulate Megan. That's been a monumental job that she's been doing. Toward the Northwest Indiana Hohman, LLC, which is the bank located on, the former Bank Calumet Building, to remind you, that's a $\$ 28$ million investment. One hundred market rate units. Eight thousand square foot of retail space. They received $\$ 6$ million in TIF. We had to change that because of some things that happened with inflation and supply chain issues. Everything's going really well there. I know the Council also had a tour of the building. I think it's going swimmingly. Looking forward to it opening. I met with firefighters at Station 8. I forgot what shift it was but we had our normal meeting with them. We held Mayor's Night Out in the $2^{\text {nd }}$ District. I want to thank Councilman Torres for hosting a lively Mayor's Night Out. Well attended. Update you on Norfolk Southern update, we had a community meeting on Norfolk Southern. The Governor's Parkway proposal is a $\$ 12$ million bridge. We will be receiving about $\$ 10$ million from INDOT. INDOT's designing and constructing the bridge. We are merely bystanders watching this take place. What we do is give the other $20 \%$, that's about all we do. If we're chosen by INDOT to go ahead and go forward with this. I acknowledge that Governor's Parkway in itself does not solve $100 \%$ of the problems that were identified in Hessville when you have stopped trains. But I think this is going to solve a lot of them, $75 \%$ of the problems. The other $25 \%$ of the problems are caused when kids who live south of Orchard, south of Scott Middle School, they get blocked by the Norfolk Southern that are tempted to use, to cross the trains by foot or to climb over the stopped trains. That situation won't be solved most likely with Governor's Parkway. However, I do want to point out that the city's administration is in discussion with Norfolk Southern as we speak. The Federal Railroad Administration is involved. It's going very well. I think that I'll be happy to report, down the road, that we're gonna solve the other $20-25 \%$ of the other problems in Hessville, which is the kids that are

Mayor McDermott cont. - tempted to climb over stopped trains. I, myself, spoke with the CEO of Norfolk Southern. We had a great conversation. Federal Railroad Association is very involved. Secretary Pete Buttigieg is paying attention and very involved from Washington, D.C. I think that for the first time in a long time, people are listening to us and our complaints about trains. Without that article in ProPublica, none of this is happening. So I do want to say thank you to those reporters that did that article. It got attention across the country. It's a scary situation. So, a couple more things, I'm almost done. Four sand volleyball courts are being added to the Sportsplex, we knew that. The Department of Public Works' employees are doing the project. I'm funding it out of Mayor's Gaming. They got it dug out. Everything's on order. It should be up and running by summer. The Festival of the Lakes line up is set. I think most people know the line up. Wed., July 12, Ashanti and JaRule; Thur., July 13, Brothers Osborne; Fri., July 14, Stone Temple Pilots; Sat., July 15, lil Wayne, ticketed event; Sun., July 16, El Flaco. Last but not least, I know today we have a resolution on the agenda to dedicate an honorary street designation in honor of Frank Van Til. Everybody in this room knows who Frank Van Til is. He's a legend in the city of Hammond. Born in 1946. His first home was on the corner of Jackson and Vine, in the back of the first Van Til's grocery store. Van Til's Supermarket, where he worked in may capacities including egg sorter, stocker and produce, before becoming a store manager. He's been awarded, Frank Van Til's been awarded Lakeshore Chamber's Man of the Year, Lakeshore Chamber's Business of the Year, he's been given key to the City of Hammond and the community is desirous of recognizing Frank Van Til's service with a fitting and appropriate tribute which is designating the 6800 block of McCook Avenue to commemorate and remember the efforts sacrifice and all of the great things that Frank Van Til did for the city of Hammond. So, I want to thank Councilman Woerpel for carrying the ball on that situation because we couldn't have done it for a better person. If there's not any questions, I apologize to the Council for my long report and wrap up my report. I'm not sure if there's questions, Councilmen.

Councilman Woerpel - It's more of a comment than a question, but there's been quite a few people stating that the trains aren't a problem in Hessville no more. I know, since the last Council meeting I've been out there ten times in ten days there were trains blocking the crossings out there. You stated that the railroad contacted you about, you know, after that meeting and it's not like the city's sitting back and doing nothing about it. I mean, I've heard the comment being made, "Oh the trains aren't a problem no more. They just disappeared." That's not the case.

Mayor McDermott - Well, I've heard a couple things, Councilman Woerpel. I've heard that .... we've been in discussions, active discussions, with Norfolk Southern and FRA (Federal Railroad Administration) and from what I, I don't live in Hessville, I live in Woodmar. I drive through Hessville almost every day. I haven't ... I saw a train stopped there the other day. But from what I hear from people that live closer to the tracks, is that it's gotten better since the ProPublica article. Now, if this is the case, I don'r want to bet Hammond's future, Hessville's future, on it's gonna stay that way a year from now, five years from now, ten years from now, when everybody forgot about that newspaper article. The fact is, the only way to get us around and over these stopped trains is to build bridges. It's not gonna get stopped by the State of Indiana because the State is powerless. You're not gonna see it stopped by the city of Hammond because we are powerless. Washington, D.C. isn't doing anything about it. If we build bridges, they can't stop us. So, I think between the two proposals that we are talking about, which is Governor's Parkway, the bridge that INDOT's financing, that's gonna take care of most of the problem, and I acknowledge there still are some problems, that's why we're talking about the second

Mayor McDermott cont. - bridge. We have identified an area where the bridge would work. We've identified what would be necessary for that to happen and now we're trying to wrap up the resources to get it done and if we do both of these bridges, I could look anybody who lives in Hessville straight in the face and say, "We fixed your problem." We did. It's still gonna stop. Those trains are still gonna stop, but we'll be able to function in Hessville. We'll be able to get ambulances to your house. We'll be able to get police officers to where they need to be. Right now, we can't guarantee you that. So, if it has gotten better, Councilman Woerpel, I've heard that from people in the community but I wouldn't bet our future on it. Because we got their attention right now. I think you hit while the iron is hot and the iron is white hot right now. That's why we're working with them. I do acknowledge it may have gotten better recently, but like I said, I wouldn't bet on it.
