

**BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF JUNE 6, 2024**

7504 Madison – Owner appears. Recommendation by Mr. Kalina to waive the late fee; concurred by Mr. Long. (Ins. No. 24-318)

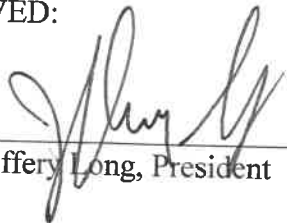
